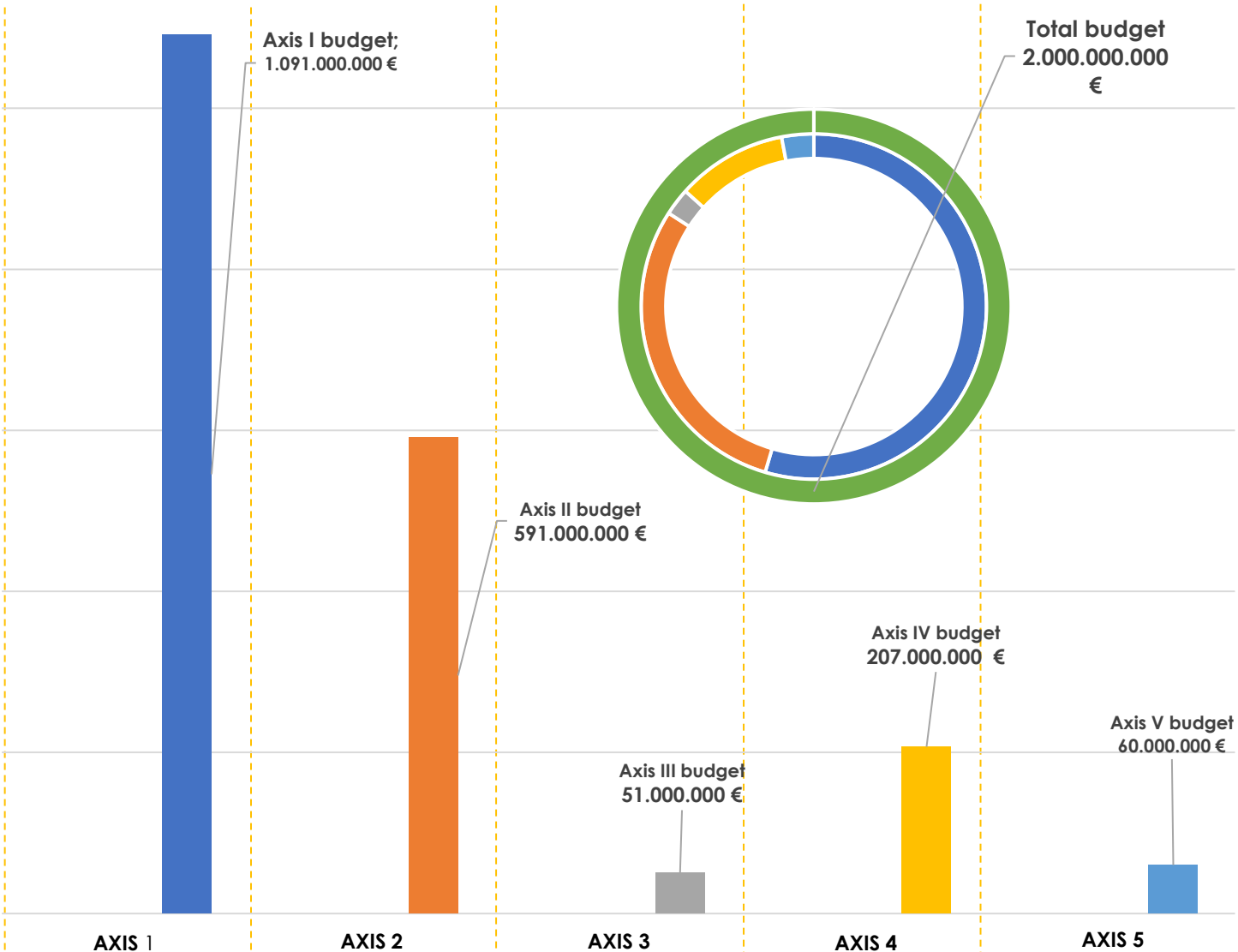

Letter from The Cohesion Policies Dept. & MiTE(Rome), Guidelines for the implementation of the DNSH principle within the RRF (Italian PNRR), December 7th, 2021:

The most appropriate stage to implement the DNSH principle within NPs and RPs funded by the European Structural & Investment Funds **is the Strategic Environmental Assessment of each program**

Four possible judgements associated to each of the six environmental parameters of DNSH, from A (not relevant, e.g. because the intervention is immaterial) to D (attention needs to be paid for possible environmental impacts, therefore, guarantees/certificates of compliance to the pertaining environmental rules need to be requested), plus ≥ 29 standards for definite kinds of intervention

Environmental Report for the SEA of the ERDF Lombardy RP (approved, as well as the RP, August 1st, 2022):

For each operation, judgements A-D are associated to each of the six environmental DNSH parameters.
Judgement «D» is expected to determine specific conditions of compliance for each call/initiative

Producers' certifications for the purchased EEE

Compliant management of the produced C&DW

Certification on purchased water supply equipments and their installation (EU Water Label)

Siting of new buildings compliant to hydraulic invariance, landscape protection, biodiversity conservation principles

NEW CALL «TOURISM»



BOTH climate change mitigation and adaptation measures to be addressed in each «infrastructural» project subsidised by the EU

Focus (and clarifications needed!) on definitions in order to bound the playing field

Coherence with the corresponding two parameters of DNSH and pre-existing environmental permitting procedures (EIA, IPPC) to be explored

Remarkable added value from region-wide climate hazard mapping



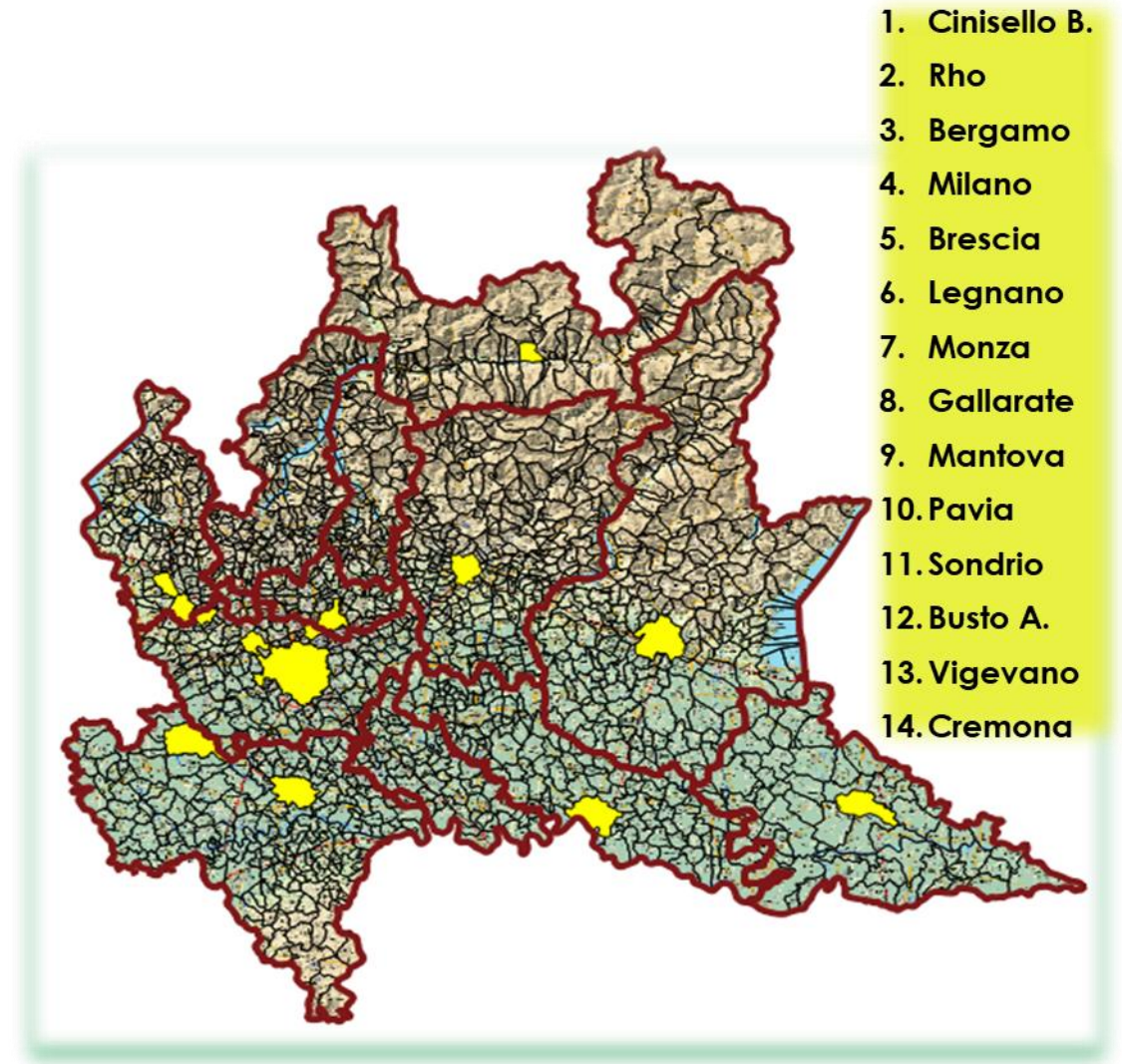

Even before the Lombardy RPs were approved, an Expression of Interest was opened to the main Lombardian cities (Province capitals + cities over 50.000 citizens)

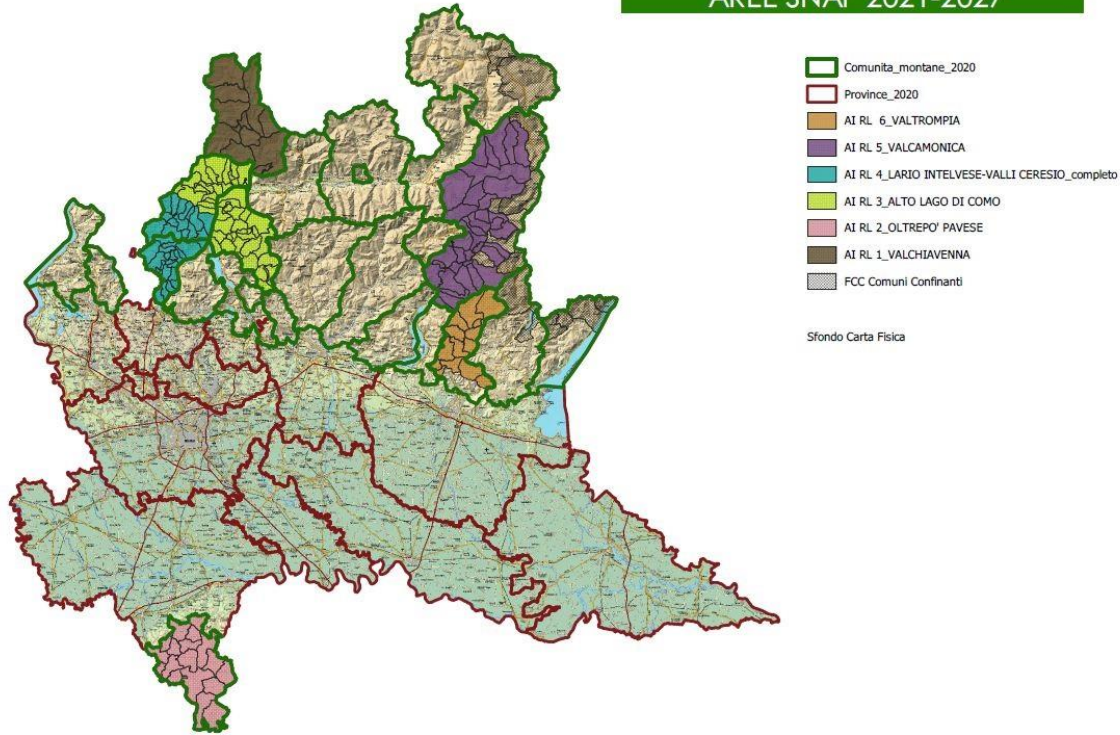

AREE SNAI 2021-2027

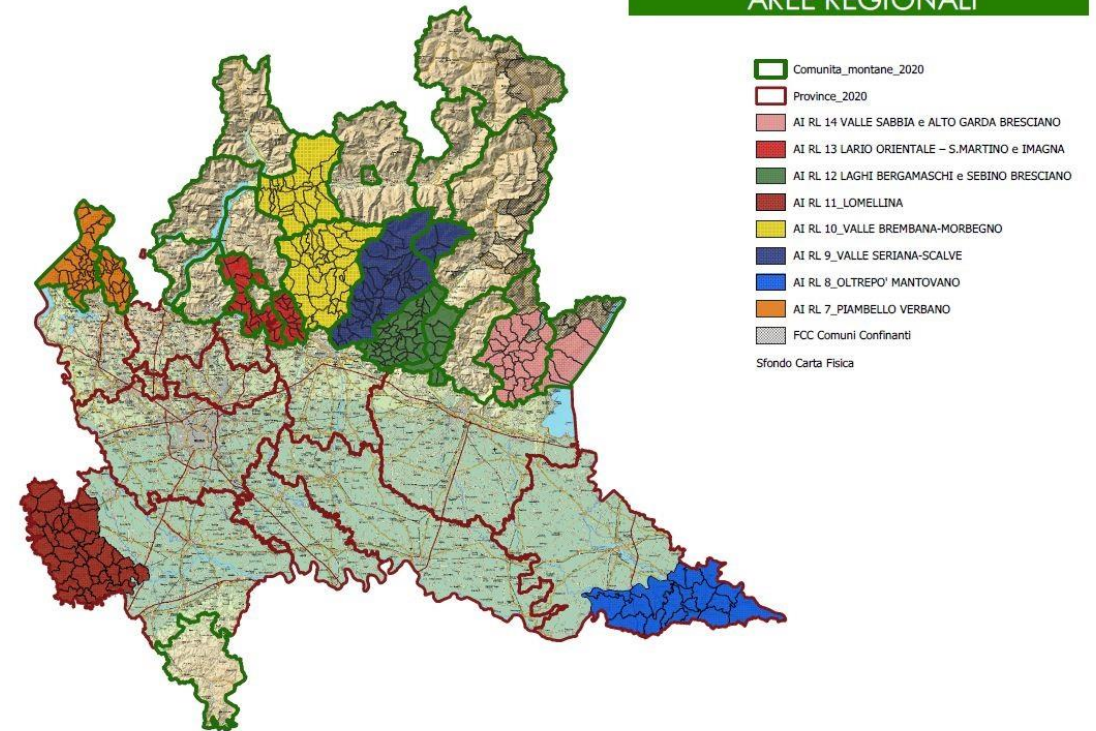
