## GREEN finance and Do No Significant Harm principle implementation for a better regional GOVernance


GeenGov, financed in 2024 among **Interreg Europe programme**, involves **11 partners** and **1 associated policy** authority, targeting nine policy instruments, including ERDF regional programs, green finance strategies and regional climate and mobility strategies.

The aim is developing by 2026 a guide for capacity building and awareness on implementing the **EU Taxonomy** principles in EU structural funds.

EU Taxonomy defines six environmental objectives for sustainable economic activities, in order to direct investments towards them. To be compliant, the investments must contribute to at least one Taxonomy objective, through three actions: adhering to the "**Do No Significant Harm**" (DNSH) principle; applying the principles of **Climate proofing** in infrastructural project; defining a scheme for **green financial instruments**.

The **Third Consortium Meeting** will be held in Milan, hosted by **Lombardy Region**, who participate with his 2021-2027 ERDF Regional Programme, on May, 26th to 28th. Beyond regional partners, will participate a panel of local stakeholders.




