





Allocation 18 000 000 EUR

Project types:

- 1. Infrastructure for recycling and other waste recovery processes
- 2. Selective collection and reception systems
- 3. Comprehensive municipal waste management projects
- 4. Environmental education

local and regional authorities and bodies acting on their behalf, waste management companies, entities providing public services in fulfilment of the local/regional authority's own responsibilities





Allocation 4 000 000 EUR

- 1. Enterprise projects for repair and reuse of items
